**Eligibility for Examinership is Degree/Post Graduate Degree and BEd. in the particular subject to which applied for. The applicants should also be handling classes in the 10<sup>th</sup> standard during the current academic year. In the case of IT subject, the school IT Co-ordinators only need to apply for Examinership. The application shall be recommended only after verifying the service conditions and eligibility for Examinership of the applicants. During previous occasions, it was noticed that certain applicants have submitted applications noting incorrect particulars of service and details of previous chances enjoyed by them. The appointment made by the Camp Officers locally will be counted as a chance. I therefore request that the applications are countersigned/ recommended only after proper verification of the details with service records. If any incorrect details are furnished, the applications will be summarily rejected and if any of the teachers happen to be selected as examiner based on any incorrect details furnished by them, their selection will be cancelled forthwith. Strict disciplinary action will be taken against the teachers and the Officers who countersign such cases.**

**Teachers can opt the camps in their respective zone only.** In the case of minor languages and minor language versions of core subjects, Zone restriction is not applicable.

The Examiners will be paid usual remuneration. They will also be paid TA & DA as per G.O.(Rt)No.1455/2004/G.Edn. dated 07.04.2004. The camp will last for about three weeks. The time of work will be from 9.30 AM to 5 PM. **Each Examiner will have to value 36 scripts per day except English, Social Science, Maths & IT. In the case of English, Social Science and Maths each Examiner will have to value 24 scripts and for IT 64 scripts.** They will have to make their own arrangements for boarding and lodging. However there is no objection for using the school building allotted by Camp Officer for the purpose for their accommodation.

Before countersigning the applications, the Officers should see that the applications have been duly filled up with the correct information by the applicants. **Whether the application is for appointment as Assistant Examiner or as Additional Chief Examiner should be clearly stated by scoring off what is not required.**

**The applicants should fulfill the following conditions.**

1. Those who will complete 3 years of service as H.S.A. as on 31.03.2010 can apply for Assistant Examinership.
2. Those who will complete 20 years of service as H.S.A as on 31.03.2010 can apply for Additional Chief Examinership.
3. **The form prescribed and appended to this communication should only be used.**
4. The last date of receipt of applications duly countersigned by Head of Schools or Controlling Officers in the Office of the Dist. Educational Officer concerned is 08 .01.2010.
5. Those who are due to retire from service on or before 30.04.2010 are not eligible to be appointed as Examiners.
6. The teachers against whom disciplinary action is pending for any reason and who are found guilty of such misconduct are not eligible.
7. Teachers of unaided schools (recognized) are not eligible to apply for Examinership. Their applications should not be forwarded for consideration on any account.
8. If anybody relinquish the appointment, the reason thereof with documental evidence if any should be forwarded through the DEO concerned.
9. If sufficient applications are not received for any subject, compulsory appointment will be made from the list of qualified teachers furnished by the DEO concerned from the respective zone.
