**ORDER**

Government have started implementation of Integrated Financial Management System (IFMS), which envisages automation of Government related transactions with all stakeholder departments and agencies. As a part of this vide GO read as 1<sup>st</sup> paper above, Government introduced an online Provident Fund Accounting System, named Government Aided Institution's Provident Fund (GAINPF) system for the management of PF accounts of employees working in all aided institutions under Director of Collegiate Education (DCE), Director of Technical Education (DTE), Director of Higher Secondary Education (DHSE), Director of Public Instructions (DPI), Director of Vocational Higher Secondary Education (DVHSE), Director of Panchayats and that under Agriculture Department, Homoeopathy Department and Ayurveda Medical Education Department with effect from 01.04.2016.

In the meeting referred as 3<sup>rd</sup> paper above, it was decided to make the online processing in GAINPF for admission and closure mandatory since the application is stabilized and is ready to proceed with the same seamlessly.

In the circumstances, now Government are pleased to introduce online processing for admission and closure in GAINPF, w.e.f. 01-01-2018. All the above PF authorities shall ensure that online applications for admission and closure will be entertained wef 01-01-2018 and necessary instructions in this regard issued to the offices/institutions under their control. The Director of Treasuries shall ensure that bills for claims under the above provident funds based on GAINPF generated sanction orders alone are passed at treasuries henceforth.
